BREEDING Pedigree: Drysdale/Kukri

Merlin (LPB06-1186) was bred by LongReach Plant Breeders, and has been extensively evaluated by the LongReach Plant Breeders technical team led by Dr Bertus Jacobs. The line was first entered into the National Variety Trials in 2008.

AGRONOMIC FEATURES

Merlin is suited to main season planting windows with early to mid season maturity similar to Crusader and Livingston in Southern NSW.

Merlin has large grain size, similar to Ellison, larger than Ventura and substantially better than Lincoln and Livingston.

Merlin also has excellent test weight, being one of the varieties with the highest TWT in NVT trials combined with acceptable screenings in over 45 trials during the past two years and is performing similarly to reliable established varieties such as EGA Gregory and is an improvement over Ventura and Ellison.
